RESOLUTION RATIFIYING ACTIONS TAKEN AT MEETING OF MARCH 6, 2012

A motion was proposed and approved confirming the seating of the Oversight Board Members; designating a contact person for Department of Finance inquiries; designating the regular time, place and location of future meetings, as well as approving the minutes of the March 6, 2012 meeting.

RESOLUTION DESIGNATING REGULAR MEETING PLACE AND TIME

It is the intent of the Oversight Board to include each of items 14, 15, 17 and 18 in the event AB1585 or a similar measure is adopted, with the Successor Agency to bring these items back with a payment schedule and interest rate limitation.

The remaining ROPS, where there were no conflicts or abstentions were **APPROVED**.
