OVERVIEW OF ABX126

The expressed major goals of the Oversight Board are to:

- Dispose of all assets and properties of the former Redevelopment Agency;
- Transfer all housing obligations from the former Redevelopment Agency to the Moreno Valley Housing Authority.

Designated time and place for future meetings to be held on the 2nd and 4th Wednesday of each month from 2 – 4 p.m. in the Council Chamber.

OVERVIEW OF RECOGNIZED OBLIGATION PAYMENT SCHEDULE (ROPS)

Staff confirmed Oversight Board must ratify existing contracts identified on the ROPS, and submit to DOF for payment and outlined priority items to discuss at next meeting.
